**Annual EEO Public File Report**

The purpose of this EEO Public File Report (“Report”) is to comply with Section 73.2080(c)(6) of the FCC’s 2002 EEO Rule. This Report has been prepared on behalf of the Station Employment Unit that is comprised of the Station WADL-TV, Mt. Clemens, Michigan, and is required to be placed in the public inspection files of this station and posted on its website.

The information contained in this Report covers the time period beginning June 1, 2015, to and including June 1, 2016 (the “Applicable Period”).

For purposes of this Report, a vacancy was deemed “filled” not when the offer was extended but when the hiree accepted the job offer. A person was deemed “interviewed” whether he or she was interviewed in person, over the telephone or by e-mail.

Section 3: WADL-TV continues to have a stable work force. WADL does not experience a great amount of turnover in full time employees, with the exception of Master Control Operators and Sales Assistant within this past year. However, WADL-TV has taken steps over the last year to achieve a broad and inclusive outreach in the community for actual vacancies and positions that have opened up for full time employment.

During the last year, 6/2015-6/2016, there were 3 full time positions open at WADL-TV , and were filled Specs Howard College Central website, Referral and Wayne State University.

WADL-TV participated in Five (5) job fairs during that period at the following institutions:

In general, the station does many different types of job fairs to promote EEO in the Metro Detroit Communities. All resumes obtained from the job fairs are kept on file at the station in an event a vacancy opens up.

WADL-TV also reaches out to offer internships to current college students at local colleges majoring in broadcasting/cinematic arts programs during all job fairs, On 6/15/15, WADL welcomed Central Michigan University intern into our station which earned him 6 credit hours during the summer of 2015 semester.
